- **IN-PERSON REQUESTS:** VISITING THE COUNTY OFFICE CAN HELP IF YOU PREFER SPEAKING DIRECTLY WITH A REPRESENTATIVE OR NEED CERTIFIED COPIES OF YOUR PAYMENT HISTORY.
- **PHONE ASSISTANCE:** CONTACTING THE COUNTY OFFICE BY PHONE CAN HELP CLARIFY ANY QUESTIONS ABOUT YOUR PROPERTY TAX STATUS OR PAYMENT HISTORY.

USING THE ONLINE SYSTEM IS OFTEN THE QUICKEST AND MOST EFFICIENT WAY TO OBTAIN YOUR TAX PAYMENT HISTORY, ALLOWING YOU TO DOWNLOAD STATEMENTS AND RECEIPTS INSTANTLY.

HOW PROPERTY TAXES WORK IN VENTURA COUNTY

TO APPRECIATE THE IMPORTANCE OF YOUR PROPERTY TAX PAYMENT HISTORY, IT'S HELPFUL TO UNDERSTAND HOW PROPERTY TAXES ARE CALCULATED AND COLLECTED IN VENTURA COUNTY.

ASSESSMENT AND TAX RATES

IN VENTURA COUNTY, PROPERTY TAXES ARE PRIMARILY BASED ON THE ASSESSED VALUE OF YOUR PROPERTY. THE VENTURA COUNTY ASSESSOR'S OFFICE DETERMINES THIS VALUE, TYPICALLY BASED ON THE PURCHASE PRICE OR MARKET VALUE, SUBJECT TO ANNUAL ADJUSTMENTS AND PROPOSITION 13 LIMITS. UNDER PROPOSITION 13, THE ASSESSED VALUE CAN ONLY INCREASE BY A MAXIMUM OF 2% PER YEAR UNLESS THE PROPERTY CHANGES OWNERSHIP OR UNDERGOES SIGNIFICANT IMPROVEMENTS.

THE BASIC PROPERTY TAX RATE IN VENTURA COUNTY IS APPROXIMATELY 1% OF THE ASSESSED VALUE. HOWEVER, ADDITIONAL VOTER-APPROVED ASSESSMENTS AND SPECIAL DISTRICT TAXES CAN INCREASE THE TOTAL TAX BILL.

PAYMENT SCHEDULE AND DEADLINES

PROPERTY TAXES IN VENTURA COUNTY ARE USUALLY BILLED TWICE A YEAR: THE FIRST INSTALLMENT IS DUE ON NOVEMBER 1 AND BECOMES DELINQUENT AFTER DECEMBER 10, WHILE THE SECOND INSTALLMENT IS DUE ON FEBRUARY 1 AND BECOMES DELINQUENT AFTER APRIL 10. KEEPING TRACK OF THESE DEADLINES IS ESSENTIAL TO AVOID PENALTIES AND INTEREST.

WHY IS TRACKING YOUR VENTURA COUNTY PROPERTY TAX PAYMENT HISTORY IMPORTANT?

RESOLVING DISPUTES

OCCASIONALLY, ERRORS MAY OCCUR ON TAX BILLS OR PAYMENT RECORDS. A COMPREHENSIVE PAYMENT HISTORY HELPS YOU CHALLENGE INACCURACIES AND WORK WITH COUNTY OFFICIALS TO RESOLVE DISPUTES EFFICIENTLY.

TAX PLANNING AND BUDGETING

COMMON EXEMPTIONS

- **HOMEOWNERS' EXEMPTION:** OFFERS A \$7,000 REDUCTION IN ASSESSED VALUE FOR PRIMARY RESIDENCES.
- **SENIOR CITIZEN EXEMPTIONS:** AVAILABLE FOR QUALIFIED SENIORS, OFTEN PROVIDING ADDITIONAL TAX RELIEF.
- **DISABLED VETERANS EXEMPTION:** REDUCES TAX LIABILITY FOR ELIGIBLE DISABLED VETERANS.
- **OTHER SPECIAL USE EXEMPTIONS:** INCLUDING EXEMPTIONS FOR AGRICULTURAL LAND, RELIGIOUS INSTITUTIONS, OR NONPROFIT ORGANIZATIONS.

APPLYING FOR THESE EXEMPTIONS CAN LOWER YOUR TAX BILL AND, CONSEQUENTLY, YOUR PAYMENT HISTORY WILL REFLECT THESE REDUCTIONS.

HOW TO ADDRESS ISSUES IN YOUR VENTURA COUNTY PROPERTY TAX PAYMENT HISTORY

SOMETIMES, DISCREPANCIES OR PROBLEMS ARISE WITH YOUR TAX PAYMENT RECORDS. HERE'S A STRAIGHTFORWARD APPROACH

3. **CHECK FOR DUPLICATE PAYMENTS OR CREDITS:** SOMETIMES CREDITS FROM OVERPAYMENTS OR ADJUSTMENTS MAY NOT REFLECT PROPERLY.
4. **REQUEST A FORMAL AUDIT:** IF NECESSARY, REQUEST AN AUDIT OR DETAILED STATEMENT OF YOUR ACCOUNT.
5. **CONSULT A TAX PROFESSIONAL:** FOR COMPLEX ISSUES, AN EXPERT CAN HELP NEGOTIATE OR APPEAL ON YOUR BEHALF.

IS THERE A FEE TO OBTAIN MY VENTURA COUNTY PROPERTY TAX PAYMENT HISTORY?

NO, ACCESSING YOUR VENTURA COUNTY PROPERTY TAX PAYMENT HISTORY ONLINE THROUGH THE OFFICIAL TREASURER-TAX COLLECTOR'S WEBSITE IS FREE OF CHARGE. HOWEVER, REQUESTING CERTIFIED COPIES OR DETAILED STATEMENTS BY MAIL MAY INCUR A SMALL FEE.

CAN I GET A DETAILED STATEMENT OF ALL PAST VENTURA COUNTY PROPERTY TAX PAYMENTS?

YES, YOU CAN REQUEST A DETAILED STATEMENT OF YOUR VENTURA COUNTY PROPERTY TAX PAYMENTS BY CONTACTING THE VENTURA COUNTY TREASURER-TAX COLLECTOR'S OFFICE EITHER ONLINE, BY PHONE, OR IN PERSON. THEY CAN PROVIDE A COMPREHENSIVE PAYMENT HISTORY FOR YOUR PROPERTY.

WHAT INFORMATION DO I NEED TO PROVIDE TO CHECK MY VENTURA COUNTY PROPERTY TAX PAYMENT HISTORY?

TO CHECK YOUR VENTURA COUNTY PROPERTY TAX PAYMENT HISTORY, YOU TYPICALLY NEED TO PROVIDE THE PROPERTY ADDRESS, PARCEL NUMBER (APN), OR YOUR PROPERTY TAX BILL NUMBER. HAVING YOUR IDENTIFICATION OR ACCOUNT NUMBER CAN ALSO BE HELPFUL.
